Weldor vs. Welder (There is a difference)

**Speaker - Harry W. Ebert
Part-time Consulting Welding Engineer**

While these two terms are often used interchangeably, we must pay attention how we treat the weldor (the person) and the welder (the machine). In this talk, the speaker will relate some of the observations he experienced.

Harry Ebert was a member of the first class to graduate with a Bachelor in Welding Engineering at Ohio State University. He also earned an MS from NCE (NJIT), a PE in several states, published a number of papers and was awarded with an AWS Fellowship. He worked for 50+ years before retiring from his final job as principal welding engineer supporting Exxon's worldwide fabrication and QA activities. He also taught at Marietta College and retired as a Colonel from the US Army.

In Memorium

Leonard T. Detlor

Len Detlor ('95), an AWS member for over 60 years, died on August 8, 2007 in Bethany Beach, DE. After earning his BS in engineering from Kansas State University, he joined Humble Oil, which subsequently became Exxon. During his 45 years of service, he became the engineering specialist for the Inspection Section of Exxon Research & Engineering with primary involvement in the quality control of welds. Since he showed an early interest in the nondestructive testing of welds, he served as an active contributor to Section V (Nondestructive Examination) of ASME's Boiler & Pressure Vessel Code. He also was an important instructor and highly respected mentor of the next generation of Exxon inspectors. During WWII, he served as an Army Corps of Engineers officer in the Pacific and reached the rank of Major. Back in NJ, he was actively involved with the local AWS Section, and chaired the NJ Section twice. Len was also a very active participant in the support of local charitable, family and community activities. All of us will miss Len's outstanding tutelage using his vast engineering and inspection experience.
